## Sand Creek Disc Golf Ground Rules

1. Water plays as out of bounds (OB).
2. Ball golf greens play as OB. The fringe of the ball golf green plays as in bounds. The OB line is defined by the last continuous line of fringe.
3. The perimeter road and beyond plays as OB (except hole 17). Where there is a curb present on the inbounds side of the road, the curb plays as the OB line. Areas where the curb is difficult to see are marked by painted lines or flags.
4. A missed **single mando** results in a drop within three meters inside and parallel to the mando which was missed.
5. A missed **double mando** results in a drop anywhere on the direct plane between the two mandos.
6. Sand bunkers play as hazards. Play your disc from where it lands. The hazard line is defined by the lip of the bunker. If there is no lip clearly present then the hazard line is defined by the last continuous line of grass.
7. All of the above results in a one stroke penalty.
8. Casual relief may be taken from non-permanent standing water as well as the drainage holes which are found near the perimeter of the course.

## Sand Creek Disc Golf: Long Tee Caddie Book

- \* If no special rule(s) applies to the hole then refer to the above ground rules. Special rules in the caddy book below supersede the ground rules.
- \*Tee sign pictures are superseded by the caddy book below.
- \*The caddy book below lists prominent features and OBs of each hole in order to assist the player, but does not list all features, OBs and hazards.
- \*All distances are approximate.
- \*Please do not walk on the ball golf greens.
- \*If you throw a disc into a water hazard and one of the groundskeepers goes into the water to retrieve it for you, please tip him\her 50 baht.

### **Hole 1** - Par 4 661ft\201m

- a. There is a mando on the right of the tee which must be passed on the left.
- b. There is water to the left of and across the fairway.
- c. Beyond the water on the left also plays as ob.
- d. There is a sand hazard to the left of the target area.

### **Hole 2** - Par 3 345ft\105m

- a. There is a mando off the tee which must be passed on the left.
- b. There is water on the left side, behind the short tee area.
- c. There is a sand hazard and ball golf green to the left of the target area.

### **Hole 3** - Par 4 701ft\214m

- a. There is an OB water hazard directly in front of the tee. If your disc enters this initial water hazard then please proceed to the drop zone, which is the short tee pad.
- b. There is a 2<sup>nd</sup> water hazard to the right of the fairway. This water and beyond is ob. Normal OB rules apply.
- c. There is water in front of and to the left of the target. Beyond the water onto hole 1's fairway is also OB. Normal OB rules apply.

### **Hole 4** - Par 3 245ft\75m

- a. There is a single mando in front of the tee which much be passed on the right.
- b. There is a sand hazard and ball golf green in front of the target area.
- c. There is water to the left, right and behind the target area.

**Hole 5** - Par 4 605ft\184m

- a. Off the tee, there is water straight, and to the left.
- b. As you approach the target area, please be aware of, and yield to, players teeing off on hole 6 long tee.
- c. There is water behind the target area. Beyond this water is also ob.

**Hole 6** - Par 4 349ft\106m

- a. There is water directly in front of the tee.
- b. Please be aware of, and yield to, players teeing off on the hole 7 short tee.
- c. There is a mando in front of the target area which players must pass on the right. There are two mando signs on this same tree. Only the mando facing the long tee box applies to long tee players. The other mando is for the short tees.
- d. There is a ball golf green and four sand hazards to the right of the target area.
- e. There is water to the left of the target area.

**Hole 7** - Par 3 380ft\116m

- a. There is water directly in front of the tee as well as to the left of the fairway.
- b. Water and beyond is ob on the left side of the fairway.
- c. There are two single mandos which players must pass on the left.

**Hole 8** - Par 4 619ft\189m

- a. Off the tee, there is water to the left and to the right of the fairway.
- b. There is a ball golf green and sand hazards on the far right of the target area.

**Hole 9** - Par 3 322ft\98m

- a. There is water directly in front of the tee area. This water continues along the right side for the entirety of the hole and curls partly behind the target area.
- b. If a player's tee shot enters the water hazard, then they proceed to the drop zone to the left of the target area. For any subsequent shots that enter the water hazard normal ob rules apply.
- c. There are two sand hazards and a ball golf green in front of the target area for which normal OB and hazard rules apply.
- d. All land beyond the water on the right (near the hole 10 long tee) is OB and follows the same rule as 9b.

**Hole 10** - Par 4 638ft\194m

- a. There is a mando visible off the tee which players must pass on the left.
- b. The ob perimeter road is on the left side for the entirety of the hole.
- c. There is a water hazard on the right side of the fairway which begins immediately after the mando and curves to the right towards the target area. Beyond the water is also OB.
- d. All land on the right side (near the hole 9 long tee and hole 8 target area) is OB.
- e. There is a sand hazard on the left side of the fairway.

**Hole 11** - Par 3 294ft\90m

- a. The tee pad is located in an OB area outside of the perimeter road.
- e. All OB tee shots (excluding the ball golf green) proceed to the drop zone, which is the short tee pad. For any subsequent OB shots, normal OB rules apply.
- b. There is a ball golf green and sand hazard to the right of the target area.
- c. The perimeter road curves to the right, directly behind the target area.

**Hole 12** - Par 3 448ft\137m

- a. There is water in front of the tee area, to the left of the fairway and directly behind the target area.
- b. Beyond the water on the left is also OB.
- c. Please be aware of, and yield to, players teeing off on the hole 13 long tee.

**Hole 13** - Par 5 859ft\262m

- a. There is water directly in front of the tee.
- b. There is a sand hazard on the left side of the fairway.
- c. There is a river on the left side of the fairway. All land beyond the river is also OB.
- d. There is a water hazard, ball golf green, and sand hazard around the target area.
- e. The ob perimeter road is behind the target area.

**Hole 14** - Par 3 346ft\105m

- a. There is a “giant squid” sand hazard to the left of the target area.

**Hole 15** - Par 3 293ft\89m

- a. There is a double mando off the tee.
- b. There is a ball golf green on the left side of the fairway.

**Hole 16** - Par 4 394ft\120m

- a. The ob perimeter road is on the left side for the entirety of the hole.
- b. There are three single mandos that players must pass to the left.
- c. If a shot misses the first single mando then the player should please proceed to the short tee which serves as the drop zone.
- d. If a shot misses the 2<sup>nd</sup> or 3<sup>rd</sup> single mandos then regular Sand Creek Ground Rules apply.
- e. There is a water hazard directly in front of the target area. For the left portion of the water hazard, OB is marked by flags and/or a painted line. For the right portion of the water hazard, OB is marked by the waterline.

**Hole 17** - Par 4 538ft\164m

- a. There is a double mando directly in front of the tee.
- b. There is a single mando at the end of the tunnel which players must pass on the right. This mando is not visible from the tee box but is clearly visible to those standing slightly left of the tee area. At least two players on each card should please be watching this mando in order to determine if the thrower has successfully passed the mando.
- c. There is an additional single mando further down the fairway which protects the hole 18 tee box. Players may pass this mando to the left or not pass it at all. If this mando is missed then there is drop zone marked directly next to it.
- d. The perimeter road and beyond is inbounds for the entire hole.
- e. There is a concrete wall behind the target area. Beyond the concrete wall is OB. The side of the concrete wall nearest the target area serves as the OB line.

**Hole 18** - Par 3 280ft\85m

- a. The ob perimeter road is on the left side and curves left just before the target area. Where the curb is not visible OB is marked by flags and/or a painted line.
- b. There are two sand hazards and a ball golf green to the right of the target area.
- c. There is a thin dike behind the target area. The dike and beyond are OB. The beginning of the dike, on the side nearest the target, marks the start of the OB area.
- d. The parking lot, and any concrete behind the target area, is OB
