Scores will be kept using PDGA Live Scoring (PDGA.com/score). The live scoring password is COLD.

Schedule:

This event will consist of one round with assigned tee times, and all players will begin on Hole 1. Upon arrival, all players must check in with the Tournament Director at Tournament Central, located by the practice basket and throwing net. Please plan enough time for warm-up and check-in prior to your round. Players are required to be at Hole 1 no later than 5 minutes before their scheduled tee time. Failure to be at the starting hole on time will result in a two-stroke penalty, in accordance with PDGA Rule 4.05.C.1. We look forward to a smooth and enjoyable event—thank you for helping us keep the rounds running on schedule!

Pro and am payouts, Finale invitations, and the event recap email will be sent out within 48 hours of the completion of the event.

Amateur Player Pack:

Each amateur competitor will receive:

- \$5 credit to the Power DGA Player Pack Store
- \$5 discount for the next Power DGA Qualifier hosted by Bryan on May 2nd at Joseph C. Miller Disc Golf Course

Player Pack Store vouchers will be emailed by Power DGA within 48 hours after the event. Please check your spam folder, and contact Power DGA support if you do not receive your voucher.

Your \$5 event discount for the May 2nd qualifier will use the code “Cole County” and will be automatically tied to your PDGA number.

Payout and Finale Invitations:

Payout and Finale invitations will be sent out via email within 48 hours of the end of the event. Pro payouts will be sent via PayPal. Amateur payouts will be in the form of credit to the DGPT online store and you will receive a voucher code directly from DGPT. Finale invitations will be included in the recap email sent from championship@powerdiscgolfacademy.com. Please check your spam folder if you do not receive the email!

Ace Pot

The current Ace Pot is at \$300. If no Ace is hit, Ace Pot rolls over for all future Power Disc Golf Academy Championship Series.

Final Note

This is a PDGA Sanctioned event, we will be playing by the PDGA rules. PDGA Rule Book is available on the PDGA Scoring App, uDisc, and [Official Rules of Disc Golf | Professional Disc Golf Association](#). Officiate yourselves as a group. Each player must state an opinion, majority rules, 50/50 vote goes to the player’s favor. Declare a provisional and play it both ways if applicable, and discuss it with the Tournament Director immediately after the round.
