

## Foxwood Disc Golf Course - FWO 2026 - White

### General Notes

- A. All ball-golf putting greens (shortest grass) are OB. Putting greens are not marked with paint or flags or marking systems.
- B. All ball-golf sand traps are to be played as HAZARD - play disc as it lies.
- C. Ponds and creeks are OB - UNLESS otherwise specified herein.
- D. Any disc that comes to rest beyond the perceived property lines of Foxwood, as delineated by fencing, stakes or other identifiable markings, is OB.
- E. OB other than ponds, putting greens, creeks and property lines is marked with paint and/or flags.
- F. Where paint and flags are used to mark an OB border, the paint represents the OB border and flags are for visual reference only.
- G. Where neither paint nor flags are present, the OB border is to be determined by the group.
- H. Gravel, dirt and asphalt paths are NOT OB or hazard unless otherwise specified for the hole rules.
- I. Be aware of Gold and White layout specific basket locations. This applies on holes eight and ten.
- J. Course courtesy: Please stay off all ball-golf putting greens except to retrieve OB discs. No hand carts on ball-golf greens, or tee area's.

### Layout Details

1	FWP	FWP	4	735	Forest left side is OB. All deep grass left side is HAZARD.
2	FWP	FWP	3	245	HAZARD right side and behind basket.
3	FWO	FWP	3	308	OB right - deep grass - and marked area beyond basket, extends to left side in front of creek.
4	FWP	FWP	3	285	OB beyond basket - cart path and over.
5	FWO	FWP	4	389	OB left, cart path and over. OB right, tee to basket.  Normal OB rules apply.  Creek crossing fairway is not OB, play as casual area.
6	FWP	FWO	3	255	
7	FWP	FWP	4	500	Double mandatory - disc must travel between marked trees. Drop zone marked.  OB left, past double mandatory to beyond basket - edge golf fairway as marked.
8	FWP	FWP	3	190	OB right and long.
9	FWOS	FWO	3	270	Hazard short of basket.  OB long of basket extends from pond towards 10th tee.
10	FWP	FWO	4	492	OB right side of fairway.  Creek crossing fairway is not OB, play as casual area.

11	FWO	FWP	3	305	Double mandatory - disc must travel between marked trees. Drop zone marked.  OB right and long of basket.
12	FWP	FWP	5	790	
13	FWP	FWO	3	356	OB right side.  OB left side - property line.
14	FWP	FWP	5	895	'Ball-golf fairway' is inbounds this year, rough right side is OB, between tee and water.  OB around pond and creek as marked.  OB long of basket.
15	FWP	FWP	3	255	Mandatory - disc must travel to the right of the marked tree. Drop zone marked.  OB right side
16	FWP	FWP	3	245	Mandatory - disc must travel through the two marked trees. Drop zone marked.
17	FWO	FWP	4	475	Double mandatory - disc must travel between marked trees. Drop zone marked.
18	FWP	FWO	5	710	Island green - asphalt lane, planting area's, laneway and parking lot beyond are OB - painted. Normal OB rules apply.
